# ADDENDUM AND RENEWAL OF CONTRACT BETWEEN SAGE INTERNATIONAL SCHOOL AND CALDWELL TRANSPPRTATION COMPANY, INC. FOR THE TRANSPORTATION OF STUDENTS

# **Parties to Transportation Contract:**

Sage International School, Ada County, State of Idaho Caldwell Transportation Company, Inc.

THIS ADDENDUM TO AND RENEWAL OF THE CONTRACT BETWEEN SAGE INTERNATIONAL SCHOOL AND CALDWELL TRANSPORTATION, INC. is entered into this \_\_\_\_\_ day of \_\_\_\_, by and between Sage International School, Ada County, State of Idaho, a public school district and government subdivision of the State of Idaho organized and existing by virtue of the laws of the State of Idaho, hereinafter referred to as "Sage International School"; and Caldwell Transportation Company, Inc. a duly incorporated corporation in good standing in the State of Idaho.

#### Section 1: Recitals

- 1.1 The Board of Trustees of Sage International School, Ada County, State of Idaho, has entered into negotiations with Caldwell Transportation Company, Inc., and finds that the terms and conditions of the existing Contract Between Sage International School and Caldwell Transportation, Inc. for the Transportation of Students by and between the Parties is satisfactory to the Board of Trustees, with one modification outlined in Section 2.2 and they seek to renew the Transportation Contract for an additional term of five (5) years to commence at the end of the existing term of said Transportation Contract; and
- 1.2 Caldwell Transportation Company, Inc. is agreeable to this renewal of the existing

  Transportation Contract with Sage International School for a term of five (5) years to commence
  at the end of the existing Sage International School Contract; and
- 1.3 It is necessary to provide an addendum to the Transportation Contract to provide for the renewal of the Contract for an additional five (5) year term.

#### Section 2: Transportation Contract Addendum and Renewal

In Consideration of the foregoing, and for other valuable consideration, Sage International School and Caldwell Transportation, Inc. hereby mutually agree as follows:

2.1 The term of the Transportation Contract is hereby renewed for an additional term of five (5) years, effective from July 1, 2017, and ending on June 30, 2022, {the renewal term} unless sooner terminated in accordance with the provisions of the Transportation Contract.

2.2	The rates for all services rendered under this contract will increase 2.5%. Using the Regular Da Route rates as an example, the rate for the July 1, 2017 through June 30, 2018 contract year was be calculated as follows:
